4. Attested Copies of income tax and sales tax should be furnished by the firm along with the tender.
5. Purchaser/ Competent authority may reject all bids or proposals at any time prior to be acceptance of a bid or proposal, Purchaser shall upon request communicate to any bidder, the ground for its rejection of all bids or proposal, but shall not be required to justify those grounds.
