1. Tenders (Technical + Financial) should be submitted collectively in separate envelopes marked as technical and financial.
2. Call deposit in favor of Principal Vocational Training Institute Gujrat @ 5% (as per tender document) of estimated budget (as mentioned above) should be attached with the Technical Bid.
3. Tender received after the due date & time will not be brought under consideration.
4. Attested copies of income tax and sales tax number should be furnished by the firm along with the tenders.
5. Competent authority may reject all bids / proposals at any time prior to the acceptance of a bid or proposal. Competent authority on request of bidder may communicate the grounds for rejection of any or all bids / proposals, but shall not be required to justify those grounds.
