A. Instructions to Bidders (ITB)

TERMS & CONDITIONS

All the rules and regulations, terms & conditions mentioned in this tender document will be governed, followed and executed under the PPRA rules 2014 and as amended.

1. General Instructions:

- 1.1 Any offer not received as per terms & conditions of the tender enquiry is liable to be ignored. No offer shall be considered if:
 - ◆ Received without earnest money **Rs.47,520/-** (@ 4% of estimated tender value given in tender add)
 - ◆ Not signed by authorized person on each page of tender document
 - ◆ The offer is ambiguous
 - ◆ The offer is received by fax or e-mail
 - ◆ Blacklisted firm on any ground by Procuring agency.
 - ◆ Offer received with shorter validity than required
 - ◆ The offer is not conforming to requirements indicated in the tender documents
 - ◆ Rate quoted found other than the tender documents
 - ◆ Stock of Beautician trade be provided having expiry date not less than 1 year at the time of delivery
 - ◆ Any conditional offer
- 1.2 GST & Income Tax registered, having at least three years relevant experience in Supply of items to the firms/ companies/ educational institutes are eligible to participate in the tender.
- 1.3 Offered rate will remain valid for a period of 1 Year. The contract will be enforced for a period of one year.
- 1.4 The cover envelop should indicate particulars of tender, and date of opening. The envelope must be properly sealed.
- 1.5 The earnest money / bank guarantee shall be forfeited if:
 - a. The acceptance of tender is not received within ten days of issuance of order
 - b. The offer is withdrawn, amended or revised.
 - c. The Supplier/ bidder fail to execute the contract in accordance with terms and conditions.
- 1.6 The bidder should indicate their National Income Tax No. / Sales Tax No. and circle of Income Tax Department.
- 1.7 Competent authority may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. Competent authority shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.

2. Cancellation / Penalty:

- 2.1 If the acceptance of the tender issued during the validity period of the tender is not acceptable by the bidder, the earnest money shall be forfeited.

- 2.2 In case the offer is withdrawn, amended or revised during the validity period of the tender, the earnest money shall be forfeited.
 - 2.3 In case, the bidder fails to execute the contract in accordance with the terms & conditions laid down in the contract, performance bond / bank guarantee will be forfeited and Supply/ purchase of items will be made from any other company at risk and cost of the bidder.
 - 2.4 In case of poor performance/ low standard stuff, President DBOM of VTI may cancel the contract or impose appropriate penalty. The penalty may be up to the 10% of total cost price of the supply order.
3. **Payment to the Supplier:**
 - 3.1 Payment will be made through crossed cheque to the Supplier against invoice after satisfactory performance against the supply within 30 days.
 - 3.2 Payment against partial supply will not be made.
4. **Earnest Money:**
 - 4.1 Earnest money (@ 4% of the estimated price **Rs.1, 188,000/-**) **Rs.47, 520/-** will have to be deposited along with tender. It should be in the form of Pay Order / Bank Draft / Call Deposit in favor of Principal Vocational Training Institute Yazman.
 - 4.2 Earnest money of unsuccessful bidders shall be refunded on the finalization of the contract / tender whereas the earnest money of successful bidder shall be refunded on the submission of one year performance bond/security.
5. **Performance Bond:**

One-year performance bond in the shape of CDR/ DD or bank guarantee from scheduled bank to the satisfaction of Administration of VTI equivalent to 4% of the total contract amount will have to be furnished within 10 days after the award of contract. Performance Bond will be returned after successful completion of the contract period.
6. **Inspection of Supply Items**

The Supply will be inspected by the VTI through authorized personnel who will coordinate with the Supplier in lieu of quality of Supply/ items as per tender requirements / terms & conditions of contract.
7. **Deduction of Taxes:**

Any taxes (Income Tax, GST etc.) will be deducted while making payment as per Government instructions / notifications.
8. **Payment of income tax & other taxes:**

Contract will be executed with the firms registered with income tax & GST. Income tax and all other such taxes will be liability of the bidder.
9. **Termination of Contract:**

On substandard supply or supply not conforming with the contract, The President DBOM of VTI may terminate contract and will inform to the Supplier about his decision in writing.


